Donation OF TUITION

All fees (materiel, learning, etc.), deposits, and registrations are non-refundable

Monthly Payments: \$_____ due on the 1st (pre-paid). A late fee of \$50 will be charged if tuition is not paid by the first (1st), an additional \$5 will be charge each day thereafter. If your account is not paid in full by the fifth (5th) of the month, enrollment will be suspended until your account is current. More than 3 days missed from the course you will be removed without refund.

Weekly Payments: \$_____ due on Friday before the week service is provided (pre-paid). A late fee of \$30 will be charged if tuition is not received by close of business on Friday, an additional \$5 will be charged each day thereafter. If your account is not paid in full by Wednesday, enrollment will be suspended until your account is current.

If payment in full is not received when due, I agree to pay a late payment fee per week/month or part of each week/month that tuition is not received. All late fees are subject to change without notice. I understand that if my account is delinquent according to the weekly/monthly payment of tuition terms I will be asked to withdraw until my account is made current. Payments are still due and accruing

during suspension. The University cannot guarantee your spot will be held when a you are withdrawn due to non-payment of tuition. Any unpaid tuition fees may be sent to a third-party collection agency or you may be subject to a commercial lien and garnishment. Any accounts going to collection or any outside services for collection, you will be responsible for payment of those fees.

No Checks CHECKS

I understand that a processing fee of \$50 will be charged to my account for all declined donations which are returned for any reason. This fee is in addition to any charges that my bank or financial may charge me.
